

**THE RULES OF THE COMPETITION**  
**"INTERNATIONAL FINAL OF YOUNG CAR MECHANIC 2018"**

**1. GENERAL PROVISIONS**

- 1.1. The Rules of the competition "International Finals of YOUNG CAR MECHANIC 2018" (hereinafter: the "**Competition**") define the rights and obligations of the Competition's participants.
- 1.2. The Competition is organized by Inter Cars S.A. organized by Inter Cars S.A. with its registered office in Warsaw, at ul. Powińska 64, 02-903 Warsaw, entered into the Register of Business Entities of the National Court Register kept by the District Court for the capital city of Warsaw in Warsaw, XIII Commercial Division of the National Court Register, under number KRS 0000008734, with the paid-up share capital of PLN 28,336,200.00, NIP (taxpayer identification number): 1181452946 (the "**Organizer**").
- 1.3. The Competition is organized on the territory of the Republic of Poland and will be held on 14 May 2018 in the Inter Cars Training Centre in Czostów at ul. Gdańska 27.

**2. TERMS AND CONDITIONS OF PARTICIPATION IN THE COMPETITION**

- 2.1. Participation in the Competition is voluntary and free of charge.
- 2.2. Only the finalists of the national qualification selection of the "YOUNG CAR MECHANIC 2018" competition from Poland, Lithuania, Latvia, Estonia and Bulgaria and having full legal capacity can compete in the Competition (hereinafter: the "**Participants**" or the "**Participant**").
- 2.3. The necessary condition for the Participant to join the Competition is provision by the Participant of the data and submission of the statements, whose content corresponds to the template of the Participant's Statement constituting Attachment No. 1 to the Rules.

**3. THE COMPETITION**

- 3.1. The competition comprises 5 practical tasks, which consist in carrying out diagnostics of defects in a vehicle or a training model and determining the method of their removal or performing physical repairs (hereinafter: the "**Final Tasks**").
- 3.2. The language of the Competition is English, however the rules for performance of the Final Tasks will be available to the Participants also in their native languages. If it is necessary for the Participant to provide an oral answer, the Participant may provide it in his native language or in English. The answer given by the Participant in his native language will be translated into English by the translator.

- 3.3. All Participants will have to perform the same Final Tasks.
- 3.4. Prior to the commencement of individual Final Tasks by the Participants, the Organizer shall provide them with all necessary equipment and tools as well as protective clothing.

Each Participant will have 35 minutes to complete each of the Final Tasks and the time will run from the moment the Participant reports his/her full readiness to perform the Task. Prior to the commencement of each of the Final Tasks, the Participant will be permitted to use the assistance of the translator and get acquainted with the content of the rules for the performance of a given Final Task in their native language or in English. After reporting the readiness for the Task, the use of the translator's assistance by the Participant is not permitted.

- 3.5. The Participants undertake to complete all Final Tasks independently, relying solely on their own knowledge, skills and experience.
- 3.6. The winners will be selected by the competition committee appointed by the Organizer, consisting of persons appointed by the Organizer (hereinafter: the "**Competition Commission**") on the basis of the points awarded to the Participants for the completed Final Tasks. The Participant can be awarded a maximum of 50 points for completing each of the Final Tasks. The number of points awarded will depend on the degree of difficulty of the Tasks and the manner and quality of their completion by the Participants, and in the event that the Final Task is not completed - also the degree of its advancement. Immediately after completing each of the Final Tasks, a protocol will be made, stating the number of points scored by the Participant, signed by the Participant and a member of the Competition Commission.
- 3.7. During the performance of each of the Final Tasks by the Participant the only person that may be present at the workplace is a member of the Competition Commission assessing the Participant. The attendance of any other third parties, in particular the teachers, is not permitted.
- 3.8. The Competition Commission will select a total of 3 winners, awarding them position, respectively from I to III (hereinafter: the "**Finalists**"). An additional differentiating criterion, if the Participants get the same number of points, will be the time of solving the Final Tasks - the shorter it is, the higher the Participant's position.

#### 4. **PRIZES**

- 4.1. The prizes for winning the Competition are awarded to the Finalist, the school attended by the Finalist (hereinafter the "**School**") and the teacher preparing the Finalist to the Competition (hereinafter: the "**Teacher**").

- 4.2. The prizes include:
- 4.2.1. for the first place, the prizes of a total value of PLN 50,000 (11 821 EUR), which consist of:
- a. a cash prize of PLN 10,000 (about 2364 EUR ) for the Finalist;
  - b. a cash prize of PLN 5,000 ( about 1182 EUR) for the Teacher;
  - c. any chosen items in the Organizer's online store - [www.sklep.intercars.com.pl](http://www.sklep.intercars.com.pl) or a training package carried out in the Inter Cars Training Center or revitalization of the School provided on the terms set out in Attachment No. 2 to the Rules - with a total value of PLN 35,000 ( about 8275 EUR ) - for the School.
- 4.2.2. for the second place, the prizes of a total value of PLN 30,000 ( about 7093 EUR ), which consist of:
- a. a cash prize of PLN 6,000 ( about 1418 EUR ) for the Finalist;
  - b. a cash prize of PLN 3,000 ( about 709 EUR ) for the Teacher;
  - c. any chosen items in the Organizer's online store - [www.sklep.intercars.com.pl](http://www.sklep.intercars.com.pl) or a training package carried out in the Inter Cars Training Center or revitalization of the School, provided on the terms set out in Attachment No 2 to the Regulations) - with a total value of PLN 21,000 ( about 4965 EUR ) - for the School.
- 4.2.3. for the third place, the prizes of a total value of PLN 20,000 ( about 4728 EUR) , which consist of:
- a. a cash prize of PLN 4,000 ( about 945 EUR) for the Finalist;
  - b. a cash prize of PLN 2,000 ( about 472 EUR) for the Teacher;
  - c. any chosen items in the Organizer's online store - [www.sklep.intercars.com.pl](http://www.sklep.intercars.com.pl) or a training package carried out in the Inter Cars Training Center or revitalization of the School, provided on the terms set out in Attachment No 2 to the Regulations) - with a total value of PLN 14,000 ( about 3310 EUR ) - for the School.
- 4.3. The cash prizes will be transferred to the bank accounts numbers indicated by the Finalists and the Teachers within 7 days from the date of obtaining the data needed to make the payment by the Organizer. At the same time, the data may not be transferred earlier than on the day of the announcement of the Competition's result. The Organizer will not be responsible for non-payment or a delay in payment if it occurred because the Finalist or Teacher indicated wrong personal data (name, surname, address) or an incorrect bank account number or other data necessary to make the payment.
- 4.4. The Schools can use the awarded prizes within a period no longer than one year from the day the Competition's result is announced. The prizes for the Schools are not subject to exchange or withdrawal in cash.
- 4.5. If, by force of law, the Organizer of the Competition is obliged to collect 10% of the flat rate income tax due for the prize awarded to the Participant, an additional cash prize constituting

11.11% of the value of the given prize will be awarded. The cash prize will not be paid to the Participant.

- 4.6. If the prizes cannot be handed over for the reasons being beyond the Organizer's control, the Prize will be forfeited.

## 5. **COMPLAINTS**

- 5.1. All complaints regarding the Competition with the relevant justification may be submitted only by the Participant in the form of an e-mail sent to the Organizer's e-mail address - ycm@intercars.eu, for the duration of the Competition and within a period of three days after its completion. Any complaints received by the Organizer after the above date will not be considered.
- 5.2. In addition to specification of the reason, the complaint should include the following note: complaint – the "International Finales YOUNG CAR MECHANIC 2018" competition and the name and surname of the person submitting the complaint, and the address for correspondence.
- 5.3. The submitted complaints will be considered by the Organizer immediately, but no later than within 21 days from the date of their receipt.
- 5.4. The interested parties will be notified about the resolution of the complaint by e-mail or in a written notice sent by a registered letter, no later than within 14 days from the date of the resolving the complaint.

## 6. **PERSONAL DATA**

- 6.1. The Organizer is the administrator of personal data processed in connection with the Competition.
- 6.2. The Organizer processes the information about the Participant provided in the statement, including information being personal data, subject to the applicable laws, in particular in accordance with the Personal Data Protection Act of August 29, 1997 (Journal of Laws of 2002, No. 101, item 926, as amended), in order to allow the Participant to take part in the Competition, using any security measures required in accordance with the applicable laws.
- 6.3. The Participant's data will be stored for a period not longer than as necessary in connection with the Participant's participation in the Competition and afterwards it will be removed from the system.

- 6.4. Each Participant has the right to access their personal data, correct it, supplement it and demand the cessation of data processing and its deletion. For this purpose the Participant will request the Organizer to do so in writing.

## 7. FINAL PROVISIONS

- 7.1. The Organizer has the right at any time during the Competition to exclude from the Contest the Participant (including refusal to award him the prize), whose actions grossly breach the provisions of the Rules, in particular when the Participant breaches the provisions of point 3.6. or 3.8. of the Rules.
- 7.2. The Rules are available in the Organizer's office and on the website [www.youngcarmechnic.eu](http://www.youngcarmechnic.eu).
- 7.3. The Organizer reserves the right to modify the provisions of the Rules, provided that the changes introduced do not infringe the rights acquired by the Participants during the Competition.
- 7.4. Any information about the Competition available in advertising and promotional materials is intended for information purposes only. The provisions of the Rules have the legally binding effect only.
- 7.5. In matters not regulated by the Rules, the provisions of Polish law shall apply, in particular the provisions of: the Civil Code, the Personal Data Protection Act.

## **Attachment No. 2**

### **RULES FOR IMPLEMENTATION OF THE PRIZE IN THE FORM OF THE SCHOOL REVITALIZATION SERVICE**

1. The scope of revitalization works may vary depending on many factors, in particular the size of the area on which such work would be carried out, or the School's needs. It may include, for example, painting, purchase of furniture (desks, chairs) or other elements of the School's equipment.
2. The School interested in the implementation of the prize in the form of the School's revitalization service should provide the Organizer with a detailed business plan, specifying the scope and cost of the revitalization works. The total cost of the revitalization must not exceed the value of the prize awarded to the School.
3. The business plan to which the Organizer submits no comments will be considered as the School's revitalization project. In the case of the Organizer's comments, the parties will jointly agree the final scope of the revitalization works.
4. After determining the final scope of revitalization works, the parties will agree on the works schedule. The schedule should be prepared in such a way that the revitalization works are completed no later than one year from the date of announcement of the results of the Competition.
5. The School acknowledges that the performance of revitalization works may cause a disruption of the normal work of the School, and the works may last, depending on their nature, even for one calendar month.
6. In the term of the revitalization works, the School should cooperate with the Organizer and any third parties acting on its behalf and should not cause any disturbances and limitations in



the performance of the works. The School should also follow the Organizer's instructions and recommendations, in particular regarding the preparation of the front of the works.

7. The School shall not direct any claims to the Organizer related to the manner or quality of the performed revitalization works, unless such claims arise from the Organizer's gross negligence or its willful misconduct.
8. Any liability of the Organizer related to the way the prize is implemented is limited to the value of the prize awarded to the relevant School. The Organizer is in no way liable for lost profits.
9. In the event that the School does not accept the way of performing the revitalization works or prevents their performance, it will be considered as a refusal to accept the prize. In this case, point 4.6 of the Regulations will apply.
